Nomination and application of guest license for participation of foreign riders at national horse shows in Austria (Exception national horse shows of dressage cat. A)

Reference: General regulation of FEI, Art. 105 und 123, ÖTO § 19.2

1. General terms :

Horse shows with more than 15 competitors of more than 4 countries will be considered automatically as international horse show with all associated implications according general regulation of FEI.

2. Requirements:

Declaration of agreement of home association of the rider / driver in written form.

3. Process:

- a) The rider / driver fills out the form "Nomination form and application for a guest license for national Austrian horse shows 2009" and sends it to the organizer. The declaration of agreement has to be enclosed.
- b) The organizer forwards the nomination of the foreign rider / driver to the national association of riding and driving in Austria at horse shows of category A and to the appropriate regional association of riding and driving at horse shows of category B and C **within 3 days after nomination close.**
- c) The authorising office makes out the guest license. In case of a rejection the rider / driver and the organizer will be informed.
The authorising office is allowed to restrict the quantity of guest licenses per horse show.
- d) At horse shows of category B the regional association will forward the nominations to the national association for IT registration purposes.

4. Nomination fees 2009

- a) Nomination fee for 1-day horse shows €16,00*
 Nomination fee for more-days horse shows €25,00*
 Nomination fee for eventing horse shows €25,00*
- b) You can find the fees for reservations of stables and stands in the announcement.
- c) **Delayed nominations** will be handled as "late nominations" according § 29 ÖTO.
 (Addition to nomination fee is **€36,00***)

5. Guest license fees 2009

Guest license fee for a national Austrian horse show of **category A** is **€25,00***,
for a horse show of **category B and C** is **€22,00***.
